ORDER:-

In the G.Os read above, a new wing of "Special Enforcement Bureau" have been created in General Administration Department, as an exclusive robust enforcement agency for curbing of illegal activities relating to liquor and sand and among others, ordered to amend the Second Schedule of the Andhra Pradesh Government Business Rules, 2018.

2. In the exercise of powers conferred by the clauses (2) and (3) of Article 166 of the Constitution of India, the Governor of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh Government Business Rules, 2018:-

AMENDMENT

In the said Rules,-

In Second Schedule, "Distribution of Subjects", in VII. Regulatory and Advisory Sector, at Chapter VII.1. General Administration Department, after the entries shown under D. Information and Public Relations Wing, the following shall be added namely,-

"E. SPECIAL ENFORCEMENT BUREAU WING."
