ORDER:

In the reference read above, the Assistant Registrar -cum- Drawing and Disbursing Officer, Institution of Lokayukta of Andhra Pradesh has informed that in G.O. Ms.No.161, General Administration (SR) Department, dated 31.12.2019 have allocated the posts and the employees between the Institution of Lokayukta of Andhra Pradesh and the Institution of Lokayukta of Telangana, according to which, out of the total sanctioned strength of 131 posts, only 70 posts have been allocated to the Institution of Lokayukta of Andhra Pradesh, but the Institution of Lokayukta of Andhra Pradesh is requires 131 Posts, along with the required budgetary provision, for its smooth and effective functioning, to serve the purpose for which this Institution has been established and as such, there is necessity of sanction of the remaining 61 posts to the Institution of Lokayukta of Andhra Pradesh.

2. After careful examination of the matter, Government, hereby accord administrative sanction for creation of the following eleven (11) new posts in Institution of Lokayukta of Andhra Pradesh:-
