ORDER:

In the reference first read above, Government have issued orders creating a new department viz. 'Special Enforcement Bureau' with a view to enforce, stoppage of illicit distillation, bottling and curb smuggling of alcohol as also to control illegal Sand Mining.

In the reference second read above, Government have issued orders amending above orders placing the Special Enforcement Bureau as a wing under General Administration Department, headed by Director of Police (HoPF) as the Ex-Officio Principal Secretary to Government. Government have ordered that the SEB will have a Commissioner headed by the Commissioner, who will be the Head of Department (HoD) in the rank of Inspector General of Police or above.

3. The Commissioner, Special Enforcement Bureau has requested the Government to take necessary action to notify the 'Special Enforcement Bureau' as Head of the Department (HoD).

4. Government, after careful examination of the proposal hereby decided to notify the "**Special Enforcement Bureau**" as Head of the Department (HoD) under A.P Financial Code and A.P. Treasury Code for the purposes of Financial Transactions, as required under Article 6 of Andhra Pradesh Financial Code Volume-I and Appendix 1 of Andhra Pradesh Financial Code Volume – II. Necessary amendment to Andhra Pradesh Financial Code Volume – II, Appendix shall be issued by the Finance (TFR) Department separately.

5. This order issues with the concurrence of Finance (HR-V-TFR-AL-EWF) Department vide their U.O.No.FIN01-HROTFR(FINC)/6/2020-HR-V(Computer No.1183226).
